Dear parents and carers,

Arrangements for the return to school

I hope you and your family have had a peaceful summer, despite all of the restrictions.

I wrote to you in July with some key information regarding our return to school. I am now writing to you to update you on our plans for the safe reopening of the Academy for all students, this September. We are looking forward to returning to some level of normality and being reunited with our Leesbrook family, as well as welcoming 150 new Year 7 students. Some of this guidance may be familiar from my previous letters, but, because information has changed over the summer, we have continued to work on the issue of safety and there are, therefore, some significant changes that I would like to make you aware of.

As you will know, the Government expects all students, in all year groups, to return to school full-time from the beginning of September. You can read [their guidance here](#)/or by searching for 'Guidance for full opening: schools.'

The Government have set out the actions our academy must take to minimise the risk of transmission of coronavirus, and have guided us to consider how this will impact on school operations, curriculum and behaviour, assessment and accountability, and the plans we have in place to continue education should there be a local outbreak.

Our response is to do everything that we can to maximise safety for our students, families and staff. I will summarise the arrangements in this letter, attach more detail in the accompanying document, and finally provide a shortened copy of the Government's latest advice to parents for your reference.

Summary

1. As part of Oasis Community Learning, we have completed an in-depth risk assessment which has been reviewed by the Oasis national leadership and by the Academy's local health and safety committee. The risk assessment will be updated on a weekly basis by the Academy and reported to Oasis and the local committee, who will continue to meet weekly until further notice.

As you will be aware, Oldham has had further restrictions placed upon the town. To this end, we will be following all of the government guidelines pertaining to this and encourage you all to do the same in order to keep yourself, and the community, safe.

2. In order to reduce the risk of transmission across the whole academy and each group of children, we have thought carefully about how we use the space in our Academy. We are repurposing some of the Academy to maximise the space both between students, and between students and staff.

This is in addition to how we will group our young people. Students will be taught in their Family Group Bubble, with the exception of Year 10 who will attend their option subjects in their Year Group Bubble. Students from each Year Group will be taught in one part of the school and have break and lunchtimes together. Students will have lunch within their Family Group/Year Group bubble. This will reduce the number of contacts each student has with other year groups and reduce the chance of spreading infection.

Hygiene remains an essential part of a safe return. Students and staff will be required to sanitise their hands thoroughly upon arrival at school, before and after eating, and after break times. Students will have access to hand sanitiser which will be placed in classrooms and all communal areas; please contact us directly if you have any concerns regarding potential allergies to the solution. We have hand sanitiser dispensers at all receptions, all entrances and exits, dining rooms, halls, classroom and first aid rooms.

You may consider providing your child with a personal bottle of hand sanitiser. This is especially important if your child has a skin condition or an allergy that may mean the standard sanitiser we make available is inappropriate.

Everyone will be reminded of the importance of the 'Catch it, Bin it, Kill it' approach, and we will have enough tissues and bins available throughout the school to follow this routine. Hygiene will be everyone's responsibility, including all students, to ensure we make the Academy as safe as we possibly can.

The Academy will be cleaned every day as normal, and we will be wiping down surfaces and equipment more frequently to reduce transmission of the virus. We have amended our *Strong Starts* to every lesson to include hand and desk sanitising. All lessons will end with the spot cleaning of all equipment and desks as part of the established routines.

Face Coverings

As you will no doubt be aware, the Government has mandated the use of face coverings for secondary students as they move around their school in communities where there is a high level of transmission and left it up to the discretion of schools about further use.

Again, this is a matter that Oasis has given a lot of thought to. Oasis believes that the health and safety of our students and staff is **not** a discretionary matter. **We will therefore require students to wear face coverings as they move around the building**, and all staff to wear visors when they are teaching and face coverings when social distancing is not possible.

Please see the attached document for more information and for details as to how this will work for your child.

We have reached this decision on the basis that we are of the view that everyone is responsible for everyone else's health and we trust that you will be reassured by it.

Wednesday 9 th September, 2020	New Year 7 only
Thursday 10 th September, 2020	New Year 7 and Year 8 Only
Friday 11 th September, 2020	Whole School return

Students are asked to enter and exit the Academy via the main student entrance. One again, can I stress the importance of parents not entering the school site. Please drop off on Bloom Street Car Park where we have arranged free 30 minutes parking for drop off and pick up. Whilst you may wish to walk your child to cross the road, please do not cross with them to further avoid crowding and the potential spread of the virus.

A reminder again that, should your contact details change, please update reception immediately. It is extremely important that we are able to contact parents if your child is unwell or an emergency situation occurs.

2. More details about our arrangements

1) Attendance

The Government's guidance is clear that students are expected to attend school from September following the DfE statutory guidance. This means that parents have a duty to ensure that their child regularly attends school, and that schools have a responsibility to record attendance and follow up absence.

2) Social Distancing

We will have a number of systems in place to remind students about the importance of distancing wherever possible. Classrooms will be set up in a way to maximise individual students' space. Desks will be side by side and forward facing so as to avoid students breathing over one another. There will be as much ventilation as possible. All teachers will be wearing visors when teaching.

4) Hygiene and cleaning

We will ensure that everyone understands that good hygiene is everyone's responsibility and that everyone is responsible for everyone else's health. We will maintain intensified cleaning routines with a focus on regularly wiping down door handles and hard surfaces. As per normal, the Academy will be cleaned every day and there will be disinfectant sprays and paper for cleaning purposes in each classroom.

We continue to have a stock of PPE within the Academy, including face-coverings, disposable gloves, disposable aprons, hand sanitisers and soap, if required.

5) Risk assessments

The risk assessment described overleaf has been developed following guidance from the Government and detailed guidelines from Oasis Community Learning. As explained overleaf it will be signed off by the Oasis national leadership team along with myself as Principal and will remain under constant review as we monitor our progress.

6) Getting to and from school

The Government continues to advise that students should try to avoid public transport especially at peak times and, where possible, travel to and from the Academy by walking or cycling. We know that this will not always be possible, so please let us know any concerns around this.

Wearing face coverings is a requirement for using public transport for children over 11.

7) Face Coverings and Visors

Students will be asked to follow the below guidance.

- When students arrive at school, they must safely remove their mask if they have used one whilst travelling to the academy, by using the straps rather than the front of the face covering.
- They will then be required to dispose of this mask in a covered bin, or place a reusable face coverings in a plastic bag or in their bag
- They will then be required to sanitise their hands and put on a face covering provided by the Academy for use whilst moving around the communal areas of the school.
- The Academy face covering will made of cloth and therefore is re-useable and washable. We ask that they are washed at home on a regular basis. They will be colour coded by year group and will be **treated as an item of uniform**.
- When in class, students should 'wear' the face covering around their neck and put it on their face when they are seeking support from a staff member or whenever social distancing is not possible.
- When going to the dining hall, they should wear their covering on their face until they are seated for the purposes of eating. At this point they should lower their covering to their neck. After eating, the covering should be lifted back onto their face.

Staff will be required to wear visors when teaching. They will be required also to wear a face mask when social distancing is not possible i.e. when they are supporting an individual student.

8) Water bottles and Stationary

Students are required to bring in their own water bottle for their individual use. These must be labelled and can be re-filled during the day. There will be Oasis Academy Leesbrook bottles available to buy from the Uniform shop with Mrs Robinson for £1.00. Students can also buy stationary from this shop. Students are expected to bring in all of the relevant stationary for their own personal use to avoid the spread of the virus. To remind all parents and students, equipment checks will take place each morning and all students should have:

- pens (2 black, 1 green)
- pencil
- ruler
- rubber
- calculator
- reading book
- planner (provided by the Academy, if students lose this it will cost £10.00 to replace)

9) Reduced access to outdoor visitors

To help us reduce the risk of infection, we are asking parents to communicate with us via the telephone: 0161 290 4000

There will be **NO VISITORS** permitted to enter the Academy unless there is an urgent situation. Please respect this as we are keen not to introduce potential spread of the virus.

10) Food and packed lunches

Each bubble will have a time allocated to access the dining area and hot food provision. Students may bring in packed lunches, but they must remain within their bags throughout the day, and any rubbish should be taken home each day. For those students accessing hot food, please refer to Facebook and our school website for updated menus provided by Sodexo.

11) Uniform

All students will now be required to return to full uniform. The latest Government advice is that uniforms do not need to be cleaned differently or any more often than usual because of coronavirus.

13) Suspected symptoms, a confirmed case, and multiple confirmed cases

We will be following the Government's direct guidance on what to do if a student or staff member has suspected coronavirus symptoms or is confirmed to have the virus. We have provided this guidance at the end of Government Guidance section below.

3. Government guidance

You may have questions about the Government's approach to reopening schools. I have summarised some of the [Government's latest advice](#) (updated 21st August) which I hope will address some your questions. You can read the Government's full advice by searching 'DfE parents guidance.'

Is it safe to return?

All children, in all year groups, will return to school full time from the beginning of the autumn term. The prevalence of coronavirus has decreased since schools restricted their opening to most pupils, the NHS Test and Trace system is up and running and we understand more about the measures that need to be in place to create safer environments in schools.

The scientific evidence shows that coronavirus (COVID-19) presents a much lower risk to children than adults of becoming severely ill, and there is no evidence that children transmit the disease any more than adults. There will still be risks while coronavirus (COVID-19) remains in the community, and that is why schools will be asked to put in place a range of protective measures

Attendance

It is vital that children and young people return to school and college, for their educational progress, for their wellbeing, and for their wider development. School attendance will be mandatory from the beginning of the new academic year. This means that it is your legal duty as a parent to send your child (if they are of compulsory school age) to school regularly.

If you have concerns about your child returning to school or college because you consider they may have other risk factors, you should discuss these with your school. They should be able to explain ways they are changing things to reduce risks.

Actions you can take

Do not send your child to their nursery or school if:

- They are showing [coronavirus \(COVID-19\) symptoms](#)
- Someone in their household is showing symptoms

[Arrange a test](#) if you or your child develops symptoms. Inform your nursery or school of the results.

If the test is positive, follow [guidance for households with possible or confirmed coronavirus \(COVID-19\) infection](#), and engage with the NHS Test and Trace process.

It is really important that you help nurseries and schools to implement these actions by following the advice set out here and wider public health advice and guidance.

Actions that schools will take

We have asked schools to:

- manage confirmed cases of coronavirus (COVID-19) in the school, in line with current public health guidance - this means your child may be asked to self-isolate for 14 days by their school (based on advice from their local health protection teams) if they have been in close, face to face contact with someone who has tested positive for the virus
- ensure that everyone cleans their hands more often than usual, including when they arrive, when they return from breaks, and before and after eating - this should be done for 20 seconds with soap and running water or hand sanitiser
- promote the 'catch it, bin it, kill it' approach, to ensure good respiratory hygiene
- enhance cleaning, including cleaning frequently touched surfaces more often.

Schools will minimise contact and encourage maintaining distance as far as possible. They will decide how best to do this because it will be different for each school. This will involve asking children and young people to:

- stay within specified separate groups (or bubbles)
- maintain distance between individuals

Local outbreaks

Schools will contact their local health protection team if they:

- have 2 or more confirmed cases of coronavirus among pupils or staff within 14 days
- see an increase in children or staff absence rates due to suspected or confirmed cases of coronavirus (COVID-19)

The local health protection team will advise what action is required. Usually, closure will not be necessary, but some groups may need to self-isolate. If an outbreak in a school is confirmed, a mobile testing unit may be dispatched. They will test everyone who may have been in contact with the person who has tested positive. Testing will first focus on the person's class, followed by their year group, then the whole school if necessary.

If your local area sees a spike in infection rates that results in localised community spread, the government will decide what actions need to be taken. Your child's school should provide remote education if:

- Groups of pupils need to self-isolate
- A larger restriction of attendance at school is needed

Face Coverings

Schools have the discretion to require face coverings in communal areas where social distancing cannot be safely managed, if they believe that it is right in their circumstances.

Curriculum

The Government has set out what they expect schools to teach when pupils return. Schools will provide an ambitious and broad curriculum in all subjects. There may need to be changes to some subjects, such as PE and music, so that schools can teach these subjects as safely as possible.

Extra-curricular activities

The Government advises that schools will be permitted to run breakfast and after-school activities. They must be delivered in line with the guidance on protective measures, so things may need to run things differently.

Suspected symptoms of coronavirus amongst the school community

The Academy will fully engage with the NHS Test and Trace process and contact our local Public Health England health protection team. Parents/carers need to be ready to:

- book a test if you or your child are displaying symptoms. Pupils must not come into the school if they have symptoms, and must be sent home to self-isolate if they develop.
- provide details of anyone you have been in close contact with if you or your child test positive for coronavirus or if asked by NHS Test and Trace
- self-isolate if you have been in close contact with someone who develops coronavirus symptoms or someone who tests positive for coronavirus

Anyone who displays symptoms of coronavirus should get a test. Tests can be booked online through the NHS testing and tracing website. Parents must inform us immediately of the results:

- if you or your child tests negative, and if you or your child feel well and no longer have symptoms similar to coronavirus (COVID-19), you can stop self-isolating.
- if you or your child tests positive, you should follow the 'stay at home: guidance for households with possible or confirmed coronavirus infection' and must continue to self-isolate for at least 7 days from the onset of their symptoms and your child may only return to school if they do not have symptoms other than a cough.

Confirmed case of coronavirus amongst the school community

The Academy will take swift action if we become aware that someone who has attended has tested positive for coronavirus. We will contact the local health protection team that will carry out a rapid risk assessment to confirm who has been in close contact with the person during the period that they were infectious, and ensure they are asked to self-isolate. Based on the advice from the health protection team, we would then send home those pupils who have been in close contact with the person who has tested positive, advising them to self-isolate for 14 days since they were last in close contact with that person when they were infectious. Close contact means:

- direct close contacts - face to face contact with an infected individual for any length of time, within 1 metre, including being coughed on, a face to face conversation, or unprotected physical contact (skin-to-skin)
- proximity contacts - extended close contact (within 1 to 2 metres for more than 15 minutes) with an infected individual

The health protection team will provide definitive advice on who must be sent home, and we will keep a record of pupils and staff in each bubble to help in this instance.

Household members of those contacts who are sent home do not need to self-isolate themselves unless your child who is self-isolating subsequently develops symptoms. If someone in a bubble that has been asked to self-isolate develops symptoms themselves within their 14-day isolation period they should follow 'stay at home: guidance for households with possible or confirmed coronavirus infection'. They should get a test, and:

- if the test delivers a negative result, they must remain in isolation for the remainder of the 14-day isolation period.
- if the test result is positive, they should inform us immediately, and must isolate for at least 7 days from the onset of their symptoms. Their household should self-isolate for at least 14 days from when the symptomatic person first symptoms had, following 'stay at home: guidance for households with possible or confirmed coronavirus infection'

If we have more than one confirmed case

If the Academy was to experience an outbreak (2 or more confirmed cases of coronavirus among pupils or staff within 14 days, or if there is an increase in absence due to suspected cases of coronavirus), we will contact our local health protection team. This team will advise any additional action, though the closure of the whole school will generally not be necessary.

Where an outbreak in a school is confirmed, a mobile testing unit may be dispatched to test others who may have been in contact with the person who has tested positive. Testing will focus on the person's class, their year group, the whole school, if necessary. If our local area sees a spike in infection rates, we may be advised to implement further measures.
